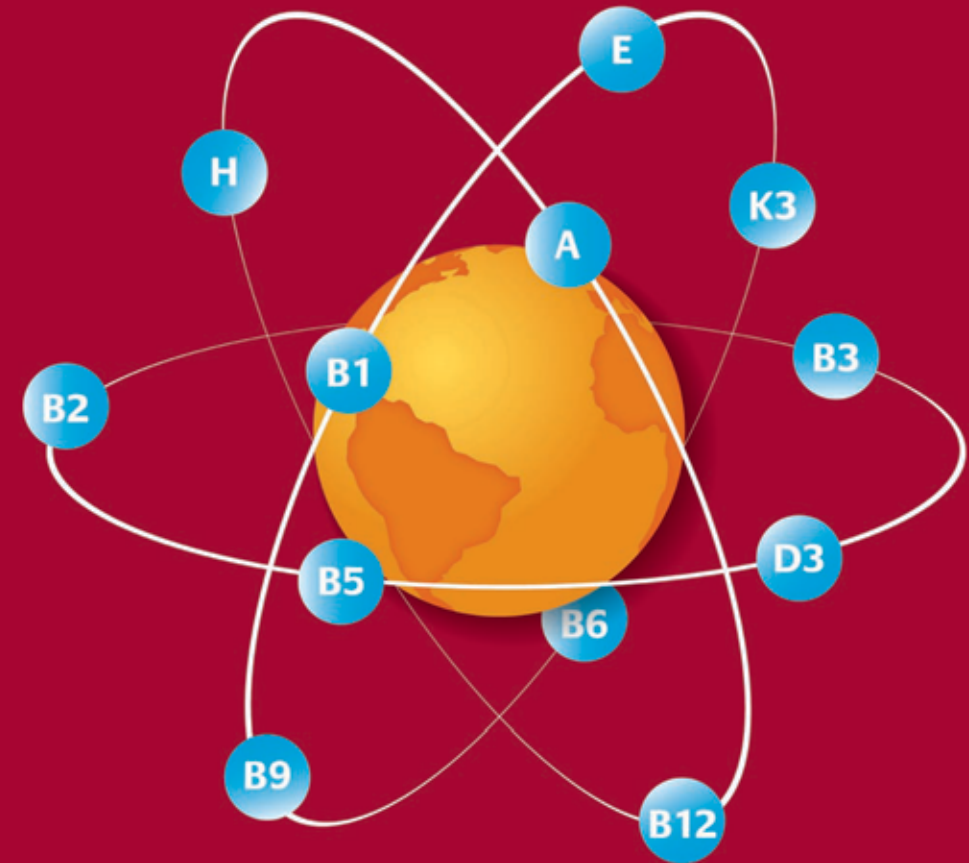

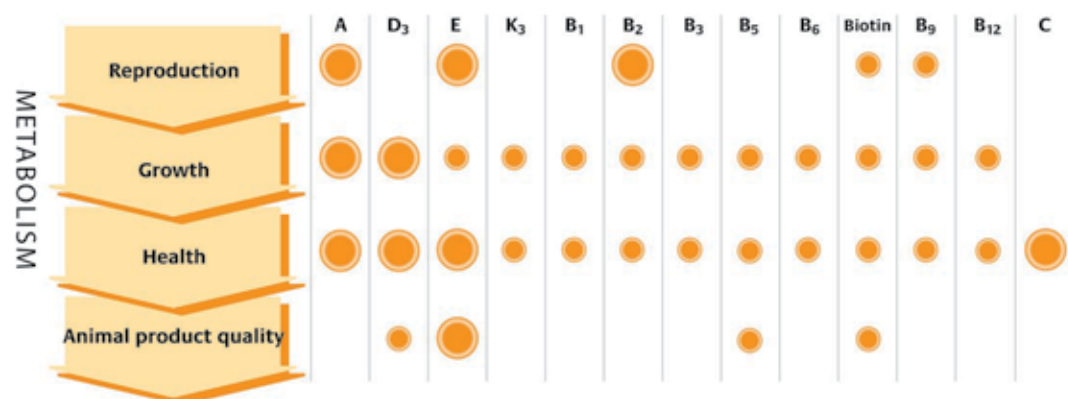

Very precise specifications concerning chemical content, physical characteristics and safety have been defined for each product.

The vitamins that Adisseo makes and sells are validated and subjected to rigorous approval process before they may receive the Microvit® label. All Microvit® suppliers must agree to comply with Adisseo's quality, safety and traceability standards.

TRACEABILITY

Microvit® products are carefully checked at each phase of the production process. Complete traceability is managed via a combination of an Adisseo-specific lot numbering program, bar coding and a global SAP system.

The Microvit® quality system is based on a global SAP system, a recognized industry standard that is used for all Adisseo business processes. It has also enabled Adisseo to become the first manufacturer of animal feed additives to be certified ISO 9001: 2000, which includes customer satisfaction criteria. The Commeny facility has also received ISO 14001 environmental and OHSAS 18000 health and safety certifications.

SAFETY

All Microvit® vitamins are produced in FAMI-QS certified plants. A vitamin becomes Microvit® after a rigorous approval process developed by Adisseo: Microvit® Certification System. MCS is a method based on the knowledge and expertise of ADISSEO. It includes multi-steps product and supplier screening, tests and audits.
